Rule change

Current rule:

Two players of the home team and one player of the visiting team shall be present by 7.30p.m. and both teams shall be complete by 8.15 p.m. The games of any player not present by 8.15 p.m. or the termination of the second set, whichever shall be later, shall go by default to the opposing team, unless otherwise agreed by the team captains.

Proposed change:

Two players of the home team and one player of the visiting team shall be present by 7.30p.m. Play should begin before 7.45 p.m., subsequent games scheduled but without players present can be claimed by the opposing team, unless otherwise agreed by the team captains. Players arriving on time for their other games based on the standard sequence will be allowed to play.
